

**CORRESPONDENTS**  
**WASHINGTON IDAHO GRAND ASSEMBLY**  
***Form due May 1***

Grand Assembly **Correspondents** will be representatives of Washington Idaho in other jurisdictions. Although **Correspondents** are not considered a Grand Officer, they will be recognized as a Grand Representative in other jurisdictions and introduced under that category during introductions.

**Requirements:** All Rainbow girls age 14 or older may apply for a **Correspondent** position by submitting the attached form to their Grand Deputy. Parents or guardians must sign their approval, as there are expenses and a time commitment. A girl does not have to be a past Worthy Advisor to apply.

A **Correspondent** must agree to attend 2 out of 3 workshops a year, follow Rainbow guidelines, meet deadlines as requested and attend Washington Idaho Grand Assembly. If serving the jurisdiction as a **Correspondent**, a girl should not expect any other appointment for Grand Assembly as it would interfere with her responsibilities during sessions.

**Correspondents** will wear matching dresses at Grand Assembly with crinoline petticoats. The cost of the dress is between \$75 - \$80. Grand Assembly guidelines prevail for hair, shoes and practices. Hair must be worn up and off the face, in french braids or short-short. **Wiglets are optional.**

**Correspondents** are encouraged to visit the jurisdiction they represent and if possible, the Grand Assembly. They must be accompanied by a parent or an authorized adult chaperone from Washington Idaho. Exceptions permitted only if host family agrees to meet girl on arrival, be responsible for her welfare during visit and take her to the airport for return flight. Authorization forms must be signed by girl's family and host family before girl departs.
